AMENDMENTS OF PUBLIC HEALTH (GENERAL SANITATION, MOSQUITO PREVENTION, RAT EXCLUSION AND PREVENTION) REGULATIONS

1. PRINCIPAL REGULATIONS

The Public Health (General Sanitation, Mosquito Prevention, Rat Exclusion and Prevention) Regulations are in these Regulations referred to as the Principal Regulations.

2. REPEAL

Regulation 32 of the Principal Regulations is repealed and the following substituted:

"32. PENALTY

"A person who contravenes or fails to comply with a direction contained in a notice served on him under regulation 31 is guilty of an offence and shall be liable, upon conviction, to a penalty of \$1000 and, where the offence is a continuing offence, to an additional penalty not exceeding \$100 for every day during which the offence continues."

3. PENALTY FOR OFFENCES

Regulation 34 of the Principal Regulations is amended by omitting "100 dollars, or" and "4 dollars" and substituting "\$1000, and" and "\$100" respectively.

4. INTERFERENCE WITH DRAINS, SCREENS, &c.

Regulation 51 of the Principal Regulations is amended by omitting "100 dollars" and substituting "\$1000 and, where the offence is a continuing offence, to an additional penalty not exceeding \$100 for every day during which the offence continues".

5. PENALTY

Regulation 57 of the Principal Regulations is amended by omitting all words after "shall be guilty" and substituting "of an offence and shall be liable upon conviction to a penalty of \$1000 and, where the offence is a continuing offence, to an additional penalty not exceeding \$100 for every day during which the offence continues".

6. GENERAL PENALTIES

Regulation 71 of the Principal Regulations is amended -

- (a) by omitting "100 dollars" and "10 dollars" and substituting "\$1000" and "\$100", respectively; and
  - (b) by omitting ", but so that the total amount shall not exceed 200 dollars".
