AMENDMENTS OF PUBLIC HEALTH (NIGHT-SOIL, GARBAGE,
CESSPITS, WELLS AND WATER) REGULATIONS

1. PRINCIPAL REGULATIONS

The Public Health (Night-Soil, Garbage, Cesspits, Wells and Water) Regulations are in these Regulations referred to as the Principal Regulations.

2. PENALTY

Regulation 22 of the Principal Regulations is amended by omitting all words after "shall be guilty" and substituting "of an offence and unless some other penalty is provided shall be liable upon conviction to a penalty not exceeding \$1000 and, where the offence is a continuing offence, to an additional penalty not exceeding \$100 for every day during which the offence continues."

3. PENALTIES

Regulation 34 of the Principal Regulations is amended by omitting "100 dollars" and substituting "\$1000 and, where the offence is a continuing offence, to an additional penalty not exceeding \$100 for every day during which the offence continues".

4. DISPOSAL OF NIGHT-SOIL

Regulation 35 of the Principal Regulations is amended by omitting "Penalty: 20 dollars for a first offence and 40 dollars for any subsequent offence."

5. INCINERATOR LATRINES

Regulation 37 of the Principal Regulations is amended by omitting "Penalty: 20 dollars for a first offence and 40 dollars for any subsequent offence."

6. INSPECTION

Regulation 38 of the Principal Regulations is amended by omitting "Penalty: 20 dollars."

7. SCALE OF LATRINES

Regulation 39(2) of the Principal Regulations is amended by omitting "Penalty: 20 dollars for a first offence against this regulation and for any subsequent offence against this regulation 100 dollars."

8. PENALTY FOR OFFENCES

Regulation 53 of the Principal Regulations is amended by omitting "100 dollars" and substituting "\$1000 and, where the offence is a continuing offence, to an additional penalty not exceeding \$100 for every day during which the offence continues".

9. INTERFERENCE WITH HEALTH SURVEYOR

Regulation 64 of the Principal Regulations is amended by omitting "Penalty: 100 dollars."

10. PENALTY

Regulation 65 of the Principal Regulations is amended by omitting "100 dollars" and substituting "\$1000 and, where the offence is a continuing offence, to an additional penalty not exceeding \$100 for every day during which the offence continues".
