AMENDMENTS OF BUILDING REGULATIONS

1. SCHEDULE 2

Schedule 2 to the Building Regulations is amended -

- (a) by omitting from Column 2 of the item "Chief Medical Officer appointed under the *Public Health Act*" in Column 1 "class 1 building" and substitute "class 1 building or a class 10 building that is ancillary to a class 1 building"; and
- (b) by omitting from Columns 1, 2 and 3 of the item "The relevant authority (either the Minister or the Northern Territory Planning Authority) in relation to a planning instrument under the *Planning Act*" in Column 1 "planning instrument" and substituting "control plan or interim development control order".

2. FURTHER AMENDMENTS

The Building Regulations are further amended as provided in the Schedule.
