AMENDMENTS OF THE SUPREME COURT RULES

1. INTERPRETATION

Rule 1.09 of the Supreme Court Rules is amended by adding at the end the following:

"(3) Unless the contrary intention appears, nothing in these Rules shall be construed as allowing the Registrar (who is not the Master) to exercise the jurisdiction of the Court (including under section 26 or 27 of the Act)."

2. APPLICATION TO COMPANIES

Rule 6.001 of the Supreme Court Rules is amended by omitting "section 528 of that Code" and substituting "section 220 of the Corporations Law".

3. HOW ORDINARY SERVICE EFFECTED

Rule 6.06(2)(c)(i) of the Supreme Court Rules is amended by omitting "section 528 of that Code" and substituting "section 220 of the Corporations Law".

4. GROUNDS OF OBJECTION TO ANSWER

Rule 30.07(1) of the Supreme Court Rules is amended by omitting paragraph (e) and substituting the following:

"(e) on the grounds of privilege;".

5. WHEN TO GIVE SECURITY

Rule 62.02(1)(f) of the Supreme Court Rules is amended by omitting "the Companies Code" and substituting "the Corporations Law".

6. CONTENT OF BILL

Rule 63.40(4) of the Supreme Court Rules is amended by omitting "item 4" and substituting "item 4 or 5".

7. FURTHER AMENDMENTS

The Supreme Court Rules are further amended as provided for in the Schedule.
