Regulations under the *Brands Act*

AMENDMENTS OF THE BRANDS REGULATIONS

1. REPEAL

Regulation 7 of the Brands Regulations is repealed.

2. BRANDS FOR HORSES AND CATTLE

Regulation 8 of the Brands Regulations is amended by inserting after "horses" the words "or cattle".

3. DISTINCTIVE BRANDS AND EARMARKS

Regulation 9(2A) of the Brands Regulations is amended by omitting "6" and substituting "4".

4. POSITION FOR BRANDS

Regulation 12(1) of the Brands Regulations is amended -

- (a) by inserting in paragraphs (a) and (b) after "3 letter" the words "or, subject to paragraph (c), distinctive"; and

(b) by omitting paragraph (c) and substituting the following:

"(c) a distinctive brand made or impressed on cattle shall be made or impressed immediately below any 3 letter brand;".

5. REGISTERED EARMARK TO BE MADE ONLY ON STOCK ALREADY BRANDED WITH A 3 LETTER BRAND OR DISTINCTIVE BRAND

Regulation 13A(1) of the Brands Regulation is amended by inserting after "brand" the words "or with a distinctive brand".

6. SIZE OF EXISTING REGISTERED BRANDS

Regulation 36A of the Brands Regulations is amended by -

(a) omitting "6" and substituting "4"; and

(b) by adding at the end the following:

"(2) A larger registered brand may, at any time without further application or fee, be reduced to the minimum prescribed size.".

7. SCHEDULE 3

(1) Schedule 3 to the Brands Regulations is amended by omitting Position 1 to Position 8 and substituting the following:

"Position 1. - Embracing off cheek or neck  
Position 2. - Embracing off shoulder  
Position 3. - Embracing off rump, hip or thigh  
Position 4. - Embracing near cheek or neck  
Position 5. - Embracing near shoulder  
Position 6. - Embracing near rump, hip or thigh".

(2) A brand applied at Position 3 (embracing off ribs) or Position 7 (embracing near ribs) of the positions described in Schedule 3 to the Brands Regulations immediately before the commencement of subregulation (1) shall be as valid and effectual as if subregulation (1) had not been made.
