Schedule 2 to the Prostitution Regulations is amended by adding at the end the forms set out in the Schedule.

3. NEW REGULATION

The Prostitution Regulations are amended by inserting after regulation 4 the following:

"5. FEE FOR GRANT OR RENEWAL OF LICENCE &C.

"(1) For the purposes of section 25(1)(e) of the Act the fee for the grant or renewal of a licence is -

- (a) in the case of an application by a body corporate -
 - (i) \$1,000; and
 - (ii) \$100 for each business name the agency will operate under; and
- (b) in the case of an application by a person other than a body corporate -
 - (i) \$400; and
 - (ii) \$80 for each business name the agency will operate under.

"(2) For the purposes of section 42(1)(b) of the Act, the fee for an inspection of the Public Register of Escort Agency Licences is \$5.

"(3) For the purposes of section 43(1) of the Act, the fee for an application to remove or vary a condition or restriction upon a licence is 50.".

- (6) It is an offence under section 7 of the Prostitution Regulation Act for a licensed operator to carry on an escort agency business in partnership with, or otherwise in conjunction with, a person who does not

have a licence to carry on that business. Maximum penalty: \$10,000. If you do so, you will probably lose your licence.

(7) Once this application has been lodged with the Board you will be investigated by the Northern Territory Police Force to assist the Board in its determination of your eligibility and suitability to be granted a licence.

- (7) It is an offence under section 7 of the Prostitution Regulation Act for a licensed operator to carry on an escort agency business in partnership with, or otherwise in conjunction with, a person who does not also have a licence to carry on that business. Maximum penalty: \$10,000. If you do so, you will probably lose your licence.
- (8) Once this application has been lodged with the Board you will be investigated by the Northern Territory Police Force to assist the Board in its determination of your eligibility and suitability to be granted a licence.
