# AMENDMENTS OF THE MARINE (EXAMINATIONS AND CERTIFICATES) REGULATIONS

#### 1. COMMENCEMENT

These Regulations shall come into operation on a date to be fixed by the Minister by notice in the *Gazette*.

## 2. PRINCIPAL REGULATIONS

The Marine (Examinations and Certificates) Regulations are in these Regulations referred to as the Principal Regulations.

### 3. INTERPRETATION

Regulation 3 of the Principal Regulations is amended by omitting paragraph (a) from the definition of "vessel" and substituting the following:

- "(a) a hire and drive vessel; ".
- 4. PRESCRIBED QUALIFICATIONS AND FORMS

Regulation 4 of the Principal Regulations is amended -  $\!\!\!\!$ 

(a) by omitting from subclause (1) "section 2" and substituting "sections 2 and 3"; and

- (b) by omitting subclause (2) and substituting the following:
- "(2) For the purposes of Division 3 of Part III of the Act, a prescribed form is a form approved by the Minister or the Director and available from the office of the Authority.".

#### 5. REPEAL OF REGULATION 5

Regulation 5 of the Principal Regulations is repealed.

#### 6. APPLICATION OF CODE

Regulation 6 of the Principal Regulations is amended by omitting "section 2, with the exception of sub-clauses 3.9.1. and 3.10.1, extends and applies" and substituting "sections 2 and 3 extend and apply".

#### CONSTRUCTION OF CODE

Regulation 7 of the Principal Regulations is amended -

- (a) by omitting "section 2" and substituting
  "sections 2 and 3";
- (b) by omitting from paragraph (b) "in the manner set out in Schedule 2" and substituting "as referring to the Department primarily responsible to the Minister for the administration of the Act".

#### 8. REPEAL AND SUBSTITUTION

Regulations 8, 9 and 10 of the Principal Regulations are repealed and the following substituted:

## "9. APPROVED QUALIFYING SERVICE

"For the purposes of the Code, 'approved qualifying service', 'watchkeeping service' and 'seagoing service' mean service assessed in accordance with the principles set out in Schedule 3 and sections 2 and 3.".

#### 9. REPEAL OF SCHEDULES 1 AND 2

Schedule 1 and 2 to the Principal Regulations are repealed.
