Regulations under the Mining Act

AMENDMENTS OF MINING REGULATIONS

1. REPEAL AND SUBSTITUTION

Regulation 7 of the Mining Regulations is repealed and the following substituted:

"7. RENT FOR EXPLORATION LICENCE

"(1) For the purposes of the Act, the prescribed rent for an exploration licence is -

- (a) \$10 for each block in the first year and second year or parts of those years;
- (b) \$20 for each block in the third year or part of that year;
- (c) \$40 for each block in the fourth year or part of that year;
- (d) \$80 for each block in the fifth year or part of that year;

"(2) The prescribed rent for an exploration licence for each year or part of a year (other than the first year) is payable within one month before the expiration of the previous 12 month period.".

2. REPEAL

Regulation 27 of the Mining Regulations is repealed.

3. REPEAL AND SUBSTITUTION

Schedule 1 to the Mining Regulations is repealed and the following substituted:
