AMENDMENT OF THE CROWN LANDS REGULATIONS

1. COMMENCEMENT

These Regulations shall come into operation on 1 December 1991.

PRINCIPAL REGULATIONS

The Crown Lands Regulations are, in these Regulations, referred to as the Principal Regulations.

3. SURRENDER OF LEASES

Regulation 32(1) of the Principal Regulations is amended by inserting, after "Minister" (first occurring), ", together with a surrender fee of \$50,".

4. REPEAL

Regulation 35 of the Principal Regulations is repealed.

5. APPLICATION FOR GRAZING LICENCES

Regulation 64 of the Principal Regulations is amended $\boldsymbol{\div}$

- (a) by omitting from subregulation (3)(a) "\$4" and substituting "\$250"; and
- (b) by omitting subregulation (3)(b) and substituting the following:
- "(b) the amount payable as rent under subregulation
 (4)."; and
- (c) by repealing subregulation (4) and substituting the following:
- "(4) The amount payable as rent shall be \$500 for the 12 month period commencing on the first day of the first month following the date of the granting of the licence.".

6. CONDITIONS OF GRAZING LICENCE

Regulation 66 of the Principal Regulations is amended by omitting paragraph (c).

7. REPEAL

Regulation 70 of the Principal Regulations is repealed.

8. RENEWAL OF LICENCE

Regulation 72 of the Principal Regulations is amended -

- (a) by omitting from subregulation (3) all words and expressions after "fee of" and substituting "\$250 and the amount payable as rent under regulation 64(4)"; and
 - (b) by omitting from subregulation (5) ", 69 and 73" and substituting "and 69".

9. REPEALS

Regulations 73 and 81 of the Principal Regulations are repealed.

· 10. REPEAL AND SUBSTITUTION

Regulation 92 of the Principal Regulations is repealed and the following substituted:
