REGISTRATION REGULATIONS

1. CITATION

These Regulations may be cited as the Registration Regulations.

2. COMMENCEMENT

These Regulations shall come into operation on the commencement of the *Registration Amendment Act 1991*.

3. FEES

The fee specified in Column 3 in the Schedule opposite the matter or thing, or service provided by the Registrar-General, specified in column 2 is required to be paid to the Registrar-General under the item specified in column 1 under the relevant Act.
