Regulations 1990, No. 29*

AMENDMENTS OF PORT BY-LAWS

1. FEE FOR PILOTAGE EXEMPTION CERTIFICATE

By-law 36 of the Port By-laws is amended -

- (a) by omitting "\$62" and substituting "\$68"; and
- (b) by omitting "\$140" and substituting "\$154".

2. FEE FOR RENEWAL OF PILOTAGE EXEMPTION CERTIFICATE

By-law 36C(2)(c) of the Port By-laws is amended by omitting "\$29" and substituting "\$32".

3. PILOTAGE RATES EXEMPTION FEE

By-law 36F(3) of the Port By-laws is amended by omitting "4.54" and "64.60" and substituting "4.98" and "70.87" respectively.

4. STORAGE CHARGE FOR INWARD CARGO

By-law 67(1) of the Port By-laws is amended -

- (a) by omitting from paragraph (a) "\$0.27" and substituting "\$0.30";

(b) by omitting from paragraph (b) "\$0.42;" and substituting "\$0.46; and"; and

(c) by omitting paragraphs (c) to (h) inclusive and substituting the following:

"(c) for the seventh day and each day thereafter - \$2.12."

5. STORAGE CHARGE FOR OUTWARD CARGO

By-law 68(2) of the Port By-laws is amended by omitting "27 cents" and substituting "30 cents".

6. POWER OF HARBOURMASTER TO REMOVE CARGO OR DO WORK ON DEFAULT

By-law 74(3) of the Port By-laws is amended by omitting "\$3.84" and substituting "\$4.21".

7. SCHEDULE 2

Schedule 2 of the Port By-laws is amended -

(a) by omitting from clause 1(a) "14 cents" and substituting "15 cents"; and

(b) by omitting from clause 1(b) "1.8 cents" and substituting "2 cents".
