AMENDMENT OF THE MOTOR VEHICLES (FEES AND CHARGES) REGULATIONS

## SCHEDULE

The Schedule of the Motor Vehicles (Fees and Charges) Regulations -

- (a) is amended by omitting item 1 and substituting the following:
- "1. Registration or renewal of registration of all motor vehicles or trailers (other than motor vehicles in respect of which another fee is provided by this Schedule):

    - (v) greater than 2 litres 13(1) but not greater than 3 litres and not included in subparagraph (iv)
- (vi) greater than 3 litres but not greater than 4 litres
- (vii) greater than 4 litres but not greater than 5 litres
- (viii) greater than 5 litres but not greater than 6 litres
  - (ix) greater than 6 litres but not greater than 7 litres
    - (x) greater than 7 litres but not greater than 9 litres
  - (xi) greater than 9 litres 13(1)but not greater than 12 litres
- (xii) greater than 12 litres 13(1)
- (xiii) maximum charge for any 13(1) \$90.00 motor tractor

- \$6.00 per 250 milli-13(1) litres or part thereof
