

#### Regulations 1988, No. 37\*

#### Regulations under the Registration of Births, Deaths and Marriages Act

I, ERIC EUGENE JOHNSTON, the Administrator of the Northern Territory of Australia, acting with the advice of the Executive Council, make the following Regulations under the Registration of Births, Deaths and Marriages Act.

#### REGISTRATION OF BIRTHS, DEATHS AND MARRIAGES REGULATIONS

#### 1. CITATION

These Regulations may be cited as the Registration of Births, Deaths and Marriages Regulations.

2. COMMENCEMENT

These Regulations shall take effect on the commencement of the *Registration of Births, Deaths and Marriages Amendment Act 1986.* 

3. PRESCRIBED PARTICULARS FOR ENTRY IN REGISTER OF BIRTHS AND REGISTER OF DEATHS

For the purposes of section 5(2) of the Act, the prescribed particulars required to be entered in -

- (a) the Register of Births are those specified in Schedule 1; and
- (b) the Register of Deaths are those specified in Schedule 2.

4. REQUEST BY REGISTRAR FOR OCCUPIER TO FURNISH PARTICULARS

(1) For the purposes of section 12(2A) of the Act, the Registrar may, by notice served on an occupier of premises in which a child is born, require the occupier, within 2 months after service of the notice, to furnish to the Registrar -

- (a) those particulars required to be furnished under section 12(1) of the Act; or
- (b) such of those particulars as the Registrar may specify in the notice.

(2) A notice under subregulation (1) may be served on an occupier by -

- (a) delivering it to the occupier personally or by electronic means;
- (b) posting it to the occupier at the address of the premises in which the child to which the notice relates was born; or
- (c) leaving it for the occupier at those premises with a person apparently employed there and who has apparently attained the age of 16 years.

(3) An occupier of premises on whom a notice under subregulation (1) is served shall, in furnishing the particulars required by the Registrar to be furnished, certify as to the correctness of those particulars.

(4) For the purposes of section 12 of the Act, the Registrar may prescribe a form for use by a person furnishing particulars under that section.

5. CHOICE OF SURNAME OF CHILD

For the purposes of -

- (a) section 17A(1) of the Act, the Registrar may, for the purpose of being satisfied that the parents of a child have agreed upon the surname of the child, request the parents to complete a form prescribed by the Registrar for that purpose and lodge it with the Registrar; and
- (b) section 17A(4) of the Act, the Registrar may, for the purpose of being satisfied of the matters referred to in paragraphs (a) and (b) of that subsection, request the parents to complete a form prescribed by the Registrar for that purpose and lodge it with the Registrar.

#### 6. CONTENT OF FORMS, CERTIFICATES AND INSTRUMENTS

A form, certificate or instrument referred in the section of the Act or the regulation specified in Column 1 of Schedule 3 shall contain the particulars specified in Column 2 of that Schedule opposite the section or regulation.

#### 7. CERTAIN FORMS, &c., TO BE SIGNED AND WITNESSED

(1) A form, certificate or instrument required or permitted to be lodged under the Act or these Regulations which is required by the Act or these Regulations to be signed by the person completing it shall be signed by that person and the signature shall be -

- (a) witnessed; or
- (b) otherwise proved, to the satisfaction of the Registrar, to have been freely given.

(2) The Registrar may accept a form, certificate or instrument required or permitted to be lodged under the Act or these Regulations notwithstanding that it -

- (a) is not strictly in accordance with the prescribed form; or
- (b) does not contain all the particulars required under the Act or these Regulations.

(3) Where the Registrar, in accordance with subregulation (2), accepts a form, certificate or instrument it shall be deemed, for the purposes of the Act or these Regulations, to be in accordance with the prescribed form or to otherwise comply with the Act or these Regulations.

#### 8. FEES

The fee for an application for the Registrar to cause a search or provide any other service in respect of an entry in an index or register kept by the Registrar is \$8.

#### 9. REPEAL OF REGULATIONS

The Registration of Births, Deaths and Marriages Regulations (Regulations 1978, No. 31) are repealed.
