Regulations 1987, No. 8*

By-laws under the *University College of the
Northern Territory Act*

The Council of the University College of the Northern Territory, in pursuance of section 43 of the *University College of the Northern Territory Act* and the approval of the Council at a meeting held on 17 February, 1986, hereby makes the following By-laws.

UNIVERSITY COLLEGE OF THE NORTHERN TERRITORY

BY-LAWS GOVERNING THE SITE

1. A person shall not enter or remain upon any part of the University College site unless he is -
 - (a) a member of the Council, a member of the teaching or research staff, or a member of the general staff of the College;
 - (b) a person pursuing a course of study at the College;
 - (c) a person who enters or remains on the site for the purpose of transacting any lawful business, provided that such business has not been prohibited by a proper authority of the College.
2. A person present on any site shall furnish his name and address when required to do so by an officer of the College.
3. The Council or any Committee or person authorised by the Council, may declare any part of a site closed to any class of persons for such period as the Council, such Committee or such person shall think fit.
4. A person shall not throw, deposit or leave on the site any rubbish, refuse, paper, bottles or litter of any kind, except in a receptacle provided for the purpose.
5. A person shall not, while on the site, use any insulting, abusive, threatening, profane, indecent or obscene language or behave in a riotous, violent, disorderly, indecent, obscene, offensive, threatening or insulting manner.

6. A person shall not, except with a permit authorising the action -

- (a) post, stick, or otherwise affix to any part of a site, or to anything thereon or give out or distribute any placard, handbill, notice, advertisement or other written, printed, stencilled or graphic matter;
- (b) write, draw, print, or paint on or deface any part of a site or anything thereon.

Provided that this by-law shall not apply to the posting of notices on noticeboards provided for such notices or the distribution of matter in the course of lawful and customary College or student activities.

7. A person shall not bring or keep or cause to be brought or kept or consumed any intoxicating liquor in the site unless authorised by the Warden to do so.

8. A person shall not bring or keep or cause to be brought or keep or consume any unlawful drug.

9. A person shall not on any part of the site, except in the course of duty or with the consent of the Warden -

- (a) cut, break, deface, pick, remove, or destroy or injure any trees, shrubs, plant or flower; or
- (b) remove, damage or interfere with any stake or label on or near any tree, shrub, plant or flower;
- (c) walk on or over or cause damage to any beds containing or being prepared for flowers or shrubs;
- (d) damage or interfere with any fence, building, erection or any fixed or moveable article on the site.

10. A person shall not, on any part of site, except in the course of duty or with a permit expressly allowing the action -

- (a) have in possession, carry or discharge any fire-arm;
- (b) have in possession, set off, or throw any fireworks;
- (c) kindle or make any fire, except where fireplaces are provided;
- (d) throw or discharge any stone or other missile.

11. A person shall not disturb, frighten, shoot at or throw missiles at any bird, fish or other animal on site or otherwise attempt to capture or kill any bird, fish or other animal on the site.

12. A person shall not on any part of a site, except with the permission of the Warden in the course of a business dealing, incidental to any activity authorised by the Warden, sell, expose, or offer for sale, lease or hire, or solicit orders for the purchase, lease, hire, of any goods, wares or merchandise or any other article or thing.

13. A person shall not remove from the site, or move from one point of the site to another any fixed or moveable article, unless authorised to do so by the Warden.

14. A person shall not, except in the course of duty or in connection with a course of study or for the purpose of consulting a member of staff bring or cause to remain on site any mammal, bird, reptile, fish or insect.

15. A person shall not organise, arrange, advertise, manage or control any fete, picnic, concert, display, including displays of film or television or performance to be held on the site unless such action is authorised by the Warden.

16. A person shall not organise, arrange, advertise, manage or control any meeting, conference, discussion, speech, preaching, or ceremony on the site other than those incidental to the customary activities of the students or staff unless such action is authorised by the Warden.

17. A person shall not on any part of the site -

- (a) bet or offer to bet or accept a bet;
- (b) sell or purchase or offer for sale or offer to purchase any ticket or coupon which purports to be for a consultation, sweep, horse-race or lottery; or
- (c) play cards for money or engage in any form of gambling.

18. A person shall not obstruct -

- (a) any employee of the University or member of the police force in the discharge of his duty;
- (b) any person in the exercise and enjoyment of any lawful activity while lawfully on the site.

19. When required to do so by an employee of the University or by a member of the police force, a person who is on site shall -

- (a) leave the site if so required;
- (b) produce for immediate inspection any permit held;
- (c) give name and address if required.

20. The Warden or a person authorised by the Warden, may notify in writing a person whose presence on the site is considered by Council or the Warden to be detrimental to the welfare of the College, that that person is forbidden to enter or remain on the site or a specified part thereof upon receipt of such notification.

21. Any person who commits breach of these by-laws shall be liable to a fine not exceeding \$200. If such a person is a student breach of these by-laws shall be misconduct and proceedings for misconduct may be taken against the student in lieu of the proceedings under the first sentence in this paragraph.
