## AMENDMENTS OF THE MOTOR VEHICLES <br> (FEES AND CHARGES) REGULATIONS

## 1. COMMENCEMENT

(1) These Regulations, other than regulation 3, shall take effect from the date of notification in the Gazette in accordance with section 63(3) of the Interpretation Act.
(2) Regulation 3 shall take effect on a date to be fixed by the Minister by notice in the Gazette.

## 2. SCHEDULE

The Schedule to the Motor Vehicles (Fees and Charges) Regulations is amended -

[^0](a) by omitting from Item 20 -
(i) "renewal of registration" and substituting "renewal of registration or any other inspection of a motor vehicle including an inspection or examination of a motor vehicle produced in accordance with a defect notice"; and
(ii) "13(1)" (twice occurring) and substituting "13(1) 128A(16)
138(af)"; and
(b) by adding at the end the following:
"28. Exemption under section 59 -
59
(a) an exemption for a period $\$ 10.00$
not longer than 7 days not requiring an inspection or prior consultation with another body or authority by the Registrar
(b) any other exemption $\$ 50.00^{\prime \prime}$.

## 3. SCHEDULE

The Schedule to the Motor Vehicles (Fees and Charges) Regulations is further amended by omitting Item 21(3) and substituting the following:
"(3) For personalized number plates -
