AMENDMENT TO WORKERS' COMPENSATION (RATES OF COMPENSATION) REGULATIONS 1986

1. CITATION

These Regulations may be cited as the Workers' Compensation (Rates of Compensation) Regulations 1986.

COMMENCEMENT

These Regulations shall be deemed to have come into operation on and to have applied from 1 July 1986.

3. DEFINITION

In these Regulations, "Act" means the Workers' Compensation Act as in force immediately before 1 July 1986.

- (g) by omitting from paragraph (1A)(b)(i)D "\$23.00" (twice occurring) and substituting "\$25.00";
- (h) by omitting from paragraph (lA)(b)(i)E "\$23.00"
 and substituting "\$25.00";
- (j) by omitting from paragraph (1A)(b)(i)F "\$23.00" and substituting "\$25.00";
- (k) by omitting from paragraph (2)(a)(ii) "\$10,646" and substituting "\$11,413"; and
- (m) by omitting from paragraph (8A) "\$2,301" (twice occurring) and substituting "\$2,467".
