WORKERS' COMPENSATION (RATES OF  
COMPENSATION) REGULATIONS 1985

1. CITATION

These Regulations may be cited as the *Workers' Compensation (Rates of Compensation) Regulations 1985*.

2. COMMENCEMENT

These Regulations shall be deemed to have come into operation on and to have applied from 1 July 1985.

3. DEFINITION

In these Regulations, "Act" includes the *Workmen's Compensation Act* as in force immediately before 1 July 1985.

4. AMENDMENT OF SECTION 10(1) OF THE ACT

Section 10(1) of the Act is amended by omitting "\$54,150" and substituting "\$57,237".

5. AMENDMENT OF SCHEDULE 2 TO THE ACT

Schedule 2 to the Act is amended -

  - (b) by omitting from paragraph (1)(b) "\$22.00" and substituting "\$23.00";
  - (c) by omitting from paragraph (1)(c) "\$2,902" and substituting "\$3,067";
  - (d) by omitting from paragraph (1A)(b)(i)A "\$174.00" and substituting "\$184.00";
  - (e) by omitting from paragraph (1A)(b)(i)B "\$44.00" and substituting "\$47.00";
  - (f) by omitting from paragraph (1A)(b)(i)C "\$44.00" and substituting "\$47.00";
  - (g) by omitting from paragraph (1A)(b)(i)D "\$22.00" (twice occurring) and substituting "\$23.00";
  - (h) by omitting from paragraph (1A)(b)(i)E "\$22.00" and substituting "\$23.00";
  - (j) by omitting from paragraph (1A)(b)(i)F "\$22.00" and substituting "\$23.00";
  - (k) by omitting from paragraph (2)(a)(ii) "\$10,072" and substituting "\$10,646"; and
  - (m) by omitting from paragraph (8A) "\$2,177" (twice occurring) and substituting "\$2,301".
