Regulations under the *Police Administration Act*

AMENDMENTS OF THE POLICE ADMINISTRATION REGULATIONS

1. PRINCIPAL REGULATIONS

The Police Administration Regulations are in these Regulations referred to as the Principal Regulations.

2. INTERPRETATION

Regulation 2(1) of the Principal Regulations is amended by omitting the definition of "Sergeant" and substituting the following:

"'Sergeant' includes a Senior Sergeant."

3. RANKS OF POLICE FORCE

Regulation 3A of the Principal Regulations is amended by omitting paragraphs (d), (e) and (f) and substituting the following:

- "(d) Sergeant;
- (e) Senior Sergeant;".

4. PROMOTIONS TO BE PROVISIONAL

Regulation 11(1) of the Principal Regulations is amended by omitting "Sergeant First Class" and substituting "Senior Sergeant".

5. EXAMINATIONS

Regulation 12 of the Principal Regulations is amended by omitting subregulation (2) and substituting the following:

"(2) A member shall not apply to sit for an examination relating to promotion to the rank of -

- (a) Sergeant - unless he has completed 3 years service as a Constable; or
- (b) Senior Sergeant - unless he has gained a pass in an examination relating to promotion to the rank of Sergeant."

6. SCHEDULE 2

Schedule 2 to the Principal Regulations is amended by omitting:

"Sergeant Third Class  
Sergeant Second Class  
Sergeant First Class",

and substituting the following:

"Sergeant  
Senior Sergeant".

7. SCHEDULE 3

Schedule 3 to the Principal Regulations is amended -

- (a) by omitting from Column 1 "Sergeant Third Class" and substituting "Sergeant";
- (b) by omitting from Column 1 "Sergeant Second Class";
- (c) by omitting from Column 1 "Sergeant First Class and above" and substituting "Senior Sergeant and above";
- (d) by omitting from Column 2 "Sergeant Third Class" and substituting "Sergeant";

- (e) by omitting from Column 2 "Sergeant Second Class" and substituting "Senior Sergeant";
- (f) by omitting from Column 2 "Sergeant First Class";
- (g) by omitting from Column 3 "Sergeant Third Class" (wherever occurring) and substituting "Sergeant";
- (h) by omitting from Column 3 "Sergeant Second Class" and substituting "Senior Sergeant"; and
- (j) by omitting from Column 3 "A pass in the examination relating to the promotion to the rank of Sergeant First Class".

8. SAVINGS AND TRANSITIONAL

(1) Where immediately before the commencement of these Regulations a member held -

- (a) the rank of Sergeant Third Class, the member shall, on the commencement of these Regulations, hold the rank of Sergeant;
- (b) the rank of Sergeant Second Class, the member shall continue to hold that rank until such time as he is promoted or demoted to another rank, or resigns, retires or is dismissed from the Police Force, as if these Regulations had not come into force;
- (c) the rank of Sergeant First Class, the member shall, on the commencement of these Regulations, hold the rank of Senior Sergeant;
- (d) a pass in all sections of the examination relating to promotion to the rank of Sergeant Third Class, the member shall, on the commencement of these Regulations, be credited with a pass in the examination relating to promotion to the rank of Sergeant;
- (e) a pass in all sections of the examination relating to promotion to the rank of Sergeant First Class, the member shall, on the commencement of these Regulations, be credited with a pass in the examination relating to promotion to the rank of Senior Sergeant; and
- (f) a pass in a section of the examination last held before the commencement of these Regulations relating to promotion to the rank of Sergeant Second Class or Sergeant First Class shall, on the commencement of these Regulations, be credited as a pass in the equivalent section of the examination relating to promotion to the rank of Senior Sergeant.

(2) A credit gained before the commencement of these Regulations in an examination relating to promotion to the rank of Sergeant Second Class, other than a credit referred to in subregulation 1(f), shall lapse on the commencement of these Regulations notwithstanding regulation 18A(2) and (3) of the Principal Regulations.
