AMENDMENT OF THE BUSINESS NAMES REGULATIONS

1. COMMENCEMENT

These Regulations shall come into operation at the expiration of 14 days from the date on which the making of the Regulations is notified in the *Gazette*.

2. REPEAL AND SUBSTITUTION

The Third Schedule to the Business Names Regulations is repealed and the following substituted:
