AMENDMENTS OF THE FISH AND FISHERIES REGULATIONS

1. PRINCIPAL REGULATIONS

The Fish and Fisheries Regulations are in these Regulations referred to as the Principal Regulations.

2. DEFINITIONS

Regulation 3 of the Principal Regulations is amended by inserting after the definition of "barramundi" the following:

"'electrofishing' means the technique of stunning or killing fish using equipment which passes an electrical current between a cathode and an anode immersed in water;".

#### 3. NEW REGULATION

The Principal Regulations are amended by inserting in Part II after regulation 7A the following:

"7B. CONDITIONS FOR ABORIGINAL LICENCE FOR NON-COMMERCIAL FISHING

"Where the Director of Fisheries grants an application for a Class D licence to a member of an Aboriginal community, a condition shall be implied in the licence that the licensee shall not -

- (a) use gill-netting exceeding 200 metres in length;
- (b) use gill-netting except in waters referred to in regulation 21; or
- (c) supply or dispose of fish except to an Aboriginal community.

Penalty: \$500.".

4. REPEAL AND SUBSTITUTION

Regulation 10 of the Principal Regulations is repealed and the following substituted:

"10. TRAWLING IN CLOSED WATERS

"Where a person is licensed to engage in the Prawn Fishery, a condition shall be implied in the licence that the licensee shall not carry trawl apparatus -

- (a) in waters that are closed to trawling; or
- (b) in a river or river mouth,

unless -

- (c) the vessel carrying such apparatus is lying at anchor in an area that is recognised by the Director of Fisheries as a recognised anchorage area;
- (d) the apparatus is stowed below deck on board the vessel; or
- (e) the apparatus is suspended in board of the vessel from a mast or a boom so as to be in full view and no part of the apparatus is touching or submerged in the water.

Penalty: \$1,000.".

# 5. CLASS A2 LICENSEES

Regulation 13 of the Principal Regulations is amended by omitting "regulation 16" and substituting "regulation 10".

### 6. WATERS CLOSED TO CRABBING

The Table to Regulation 15 of the Principal Regulations is amended -

- (a) by omitting from item 3 the words "and Howard River" and substituting ", Howard River and Buffalo Creek"; and
- (b) by omitting items 6 and 7 and substituting the following:

#### 7. ILLEGAL CRABBING

Regulation 16 of the Principal Regulations is amended -

- (a) by inserting after "the licence that" the words "the licensee shall mark with a consecutive number each pot he is licensed to use and that";
- (b) by omitting from paragraph (d)(i) the words "6 cubic metres" and substituting "0.5 cubic metres".

# 8. REPEAL AND SUBSTITUTION

Regulation 18 of the Principal Regulations is repealed and the following substituted:

#### "18. DECLARATION OF BARRAMUNDI FISHERY

"(1) The industry of taking barramundi and fish of the family *Polynemidae* by any means other than trawling or crab pots is declared to be the Barramundi Fishery.

"(2) A person who is licensed in the Barramundi Fishery shall not engage in that Fishery outside the seaward limit of the Fishery defined by an imaginary line 3 nautical miles from the shore at low water mark and parallel to the shore or to a river mouth or parallel to the delineation of the river mouths described in Table 2 in regulation 21.

Penalty: \$1,000.".

9. WATERS CLOSED TO GILL-NETTING

Regulation 21 of the Principal Regulations is amended -

(a) by omitting Table 1 and substituting the following:

10. NEW REGULATION

The Principal Regulations are amended by inserting after regulation 22 the following:

"22A. TAKING FISH OTHER THAN BARRAMUNDI, &c.

"Where a person is licensed to engage in the Barrumundi Fishery, a provision shall be implied in the licence that, if the licensee establishes that a part of his catch, taken while he was genuinely fishing for barramundi or fish of the family *Polynemidae* was fish other than barramundi or fish of the family *Polynemidae*, he may, unless the Director of Fisheries directs otherwise by notice in writing, keep that other fish for sale or commercial purposes and process it.".

11. SURRENDER OF LICENCE OR UNIT OF GILL-NETTING

Regulation 23A of the Principal Regulations is amended -

(a) by omitting from sub-regulation (1A) "1983" and substituting "1984";

# (b) by inserting after sub-regulation (1B) the following:

"(1C) Where a licensee surrenders, pursuant to subregulation (1) or (1B), all the gill-netting in his possession he may apply to the Director of Fisheries for payment of \$500 for each unit of gill-netting in addition to the consideration referred to in those sub-regulations."; and

(c) by inserting in sub-regulation (3) after "sub-regulation (1)" the words "or (1B)".

12. NEW DIVISIONS

The Principal Regulations are amended by repealing Division 4 of Part III and substituting the following:

"Division 4 - Inshore Reef Fish Fishery

#### "24. DECLARATION OF INSHORE REEF FISH FISHERY

- "(1) The industry of taking from the sea -
  - (a) fin fish, other than barramundi and fish of the family Polynemidae; and
  - (b) crayfish,

by the use of gear that does not include a trawl-net, gill-net, drift-net, mobile fish trap or crab-pot, is declared to be the Inshore Reef Fish Fishery.

"(2) A person who is licensed in the Inshore Reef Fish Fishery shall not engage in that Fishery except in an area defined by an imaginary line -

- (a) on the landward limit along the shore at high water mark and a river mouth or the delineation of the river mouths described in Table 2 in regulation 21; and
- (b) on the seaward limit by a line 2 nautical miles from the shore at low water mark and parallel to the shore or a river mouth or the delineation of the river mouths described in Table 2 in regulation 21.

Penalty: \$1,000.

"25. MONTHLY RETURNS

"Where a person is licensed to engage in the Inshore Reef Fish Fishery, a condition shall be implied in the licence -

- (a) that the licensee shall, within 14 days after the end of each month, lodge with the Director of Fisheries a monthly return in a form approved by the Director of Fisheries;
- (b) that the form shall be duly completed; and
- (c) that the information contained in the form shall be true and correct in every detail.

"Division 4A - Offshore Reef Fish Fishery

"26. DECLARATION OF OFFSHORE REEF FISH FISHERY

"(1) The industry of taking from the sea -

- (a) fin fish, other than barramundi and fish of the family *Polynemidae*; and
- (b) crayfish,

by the use of gear that does not include a trawl-net, surface or midwater gill-net, or crab-pot, is declared to be the Offshore Reef Fish Fishery.

"(2) A person who is licensed in the Offshore Reef Fish Fishery shall not engage in that Fishery except in the sea seawards of an imaginary line 2 nautical miles from the shore at low water mark and parallel to the shore or to a river mouth the delineation of the river mouths described in Table 2 in regulation 21.

#### "27. MONTHLY RETURNS

"Where a person is licensed to engage in the Offshore Reef Fish Fishery, a condition shall be implied in the licence -

- (a) that the licensee shall, within 14 days after the end of each month, lodge with the Director of Fisheries a monthly return in a form approved by the Director of Fisheries;
- (b) that the form shall be duly completed; and
- (c) that the information contained in the form shall be true and correct in every detail.

#### "Division 4B - Pelagic Fish Fishery

#### "28. DECLARATION OF PELAGIC FISH FISHERY

"(1) The industry of taking from the sea fin fish, other than barramundi and fish of the family *Polynemidae*, by the use of gear that does not include a trawl-net, a bottom drift-net, handlines, automatic drop lines, fish traps or a crab-pot, is declared to be the Pelagic Fish Fishery.

"(2) A person who is licensed in the Pelagic Fish Fishery shall not engage in that Fishery except in the sea seawards of an imaginary line 2 nautical miles from the shore at low water mark and parallel to the shore or to a river mouth or the delineation of the river mouths described in Table 2 in regulation 21.

#### "28A. MONTHLY RETURNS

"Where a person is licensed to engage in the Pelagic Fish Fishery, a condition shall be implied in the licence -

- (a) that the licensee shall within 14 days after the end of each month, lodge with the Director of Fisheries a monthly return in a form approved by the Director of Fisheries;
- (b) that the form shall be duly completed; and
- (c) that the information contained in the form shall be true and correct in every detail.".
- 13. NEW DIVISION

The Principal Regulations are amended by inserting in Part III after regulation 42G the following:

"Division 11 - Special Purpose Fishery

"42H. DECLARATION OF SPECIAL PURPOSE FISHERY

"The industry of taking fish for experimental or investigation purposes or for the development of the fish and fisheries industry is declared to be the Special Purpose Fishery.

#### "42J. MONTHLY RETURNS

"Where a person is licensed to engage in the Special Purpose Fishery, a condition shall be implied in the licence -

- (a) that the licensee shall within 14 days after the end of each month, lodge with the Director of Fisheries a monthly return in a form approved by the Director of Fisheries;
- (b) that the form shall be duly completed; and
- (c) that the information contained in the form shall be true and correct in every detail.".

# 15. NEW REGULATION

The Principal Regulations are amended by inserting in Division 2 of Part VI after regulation 58 the following:

# "58A. ELECTROFISHING EQUIPMENT

"A person shall not, except in accordance with such limitations, if any, as the Director of Fisheries imposes, use electrofishing equipment to take fish.

Penalty: \$500.".
