CASINO LICENCE AND CONTROL REGULATIONS

1. CITATION

These Regulations may be cited as the *Casino Licence and Control Regulations 1984*.

2. RETURN UNDER SECTION 23(3) OF THE ACT

(1) For the purposes of section 23(3) of the Act, the return in the prescribed form containing the prescribed particulars to be supplied by a specified company to the Registrar not later than 31 January in each year is the return set out in the Schedule.

(2) The return set out in the Schedule shall be completed in accordance with such directions and instructions as are specified in the Schedule.
