

## CASINO LICENCE AND CONTROL REGULATIONS

#### CITATION 1.

These Regulations may be cited as the Casino Licence and Control Regulations 1984.

#### RETURN UNDER SECTION 23(3) OF THE ACT 2.

- (1) For the purposes of section 23(3) of the Act, the return in the prescribed form containing the prescribed particulars to be supplied by a specified company to the Registrar not later than 31 January in each year is the return set out in the Schedule.
- (2) The return set out in the Schedule shall be completed in accordance with such directions and instructions as are specified in the Schedule.
