Regulations 1984, No. 37*

Regulations under the *Motor Vehicles Act*

AMENDMENTS OF THE MOTOR VEHICLES REGULATIONS

1. COMMENCEMENT

These Regulations shall come into operation at the expiration of 14 days from the date on which the making of the Regulations is notified in the *Gazette*.

2. NEW REGULATION

The Motor Vehicles Regulations are amended by inserting after regulation 4 the following:

"4A. DEFINITIONS

"For the purposes of Form C in the Schedule -

"'laden moped mass' means the mass of an unladen moped with a full capacity of lubricating oil, coolant and fuel, plus 90 kg (including driver and instrumentation) distributed in the saddle or carrier if so equipped with a carrier;

'maximum moped speed' means the speed attainable, established by calculation or on the basis of a test, under maximum acceleration from a standing start for 1.6 km, at the laden moped mass;

'moped' means a motor vehicle being a motor cycle having 2 wheels and an engine displacement not exceeding 50 mL, with a maximum moped speed not exceeding 50 km/h, and having no provision for the manual selection of gears, the mass of which with a full capacity of lubricating oil, coolant and fuel, but without goods, occupants or equipment, shall not exceed 65 kg."

3. FORMS

The Schedule to the Motor Vehicles Regulations is amended by omitting Form C and substituting the following:

Motor Vehicles Regulations

(Back of Form C)

Class	Types of Vehicles licensed to drive
A	Motor car, moped, lorry or tractor not exceeding 4.5 tonnes G.V.M.
B	Class A and public/private hire car
C	Any motor car, moped, lorry or tractor
D	Motor omnibus plus Class A and C vehicles
E1	Motor cycle not exceeding 250 mL
E2	Motor cycle not exceeding 600 mL
E3	Any motor cycle

4. SAVINGS

Where immediately before the commencement of these Regulations there was in force a licence to drive issued in accordance with the Motor Vehicles Regulations that licence shall remain in force for the remainder of its unexpired term as if it were a licence issued in accordance with the Motor Vehicles Regulations as amended by these Regulations.

5. REPEAL

The Motor Vehicles Regulations 1980, No. 38 are repealed.
