Regulations under the Pawnbrokers Act

PAWNBROKERS REGULATIONS

1. CITATION

These Regulations may be cited as the Pawnbrokers Regulations.

2. COMMENCEMENT

These Regulations shall come into operation on the date of commencement of the Pawnbrokers Act 1980.

- 3. APPLICATION FOR LICENCE, &c.
- (1) An application for a licence or the renewal of a licence under section 7 of the Act shall be in accordance with Form 1.
- (2) An application under sub-regulation (1) shall be accompanied by -
 - (a) a fee of \$100; and
 - (b) 2 recent photographs of the applicant measuring approximately 40 mm by 50 mm.

4. OBJECTION

An objection under section 9 of the \mbox{Act} shall be in accordance with Form 2.

5. NOTICE OF HEARING

A notice of hearing in respect of -

- (a) an objection to an application under section 9(2) of the Act; or
- (b) a request for cancellation of a licence under section 15(1) of the Act,

shall be in accordance with Form 3.

6. LICENCE

A pawnbroker's licence under section 12 of the Act shall be in accordance with Form 4.

7. REQUEST FOR CANCELLATION

A request for cancellation under section 15 of the Act of a licence shall be in accordance with Form 5.

8. REGISTER

A pawnbroker shall maintain a register in the form of a bound book, which shall be kept at all times at the premises where the business of pawnbroking is carried on, and shall be available for inspection in accordance with section 34 of the Act.

9. PARTICULARS OF PAWN TO BE ENTERED IN REGISTER

For the purposes of section 20(a) of the Act, the particulars to be entered in the register by a pawnbroker in respect of a pawn are -

- (a) the name and address of the pawnbroker;
- (b) the name and address of the pawner;
- (c) the date of the pawn;
- (d) details of the pawn including -
 - (i) the amount advanced against the pawn; and
 - (ii) a description of the pawn that is sufficient to identify it;

- (e) where a redemption period exceeding 3 months has been agreed between the pawnbroker and the pawner, the length of the period and the date it expires; and
- (f) that the pawn is made in pursuance of the Act.

10. PAWN TICKET

A pawn ticket under section 20(b) of the Act shall be in accordance with Form 6.

11. RATE OF INTEREST

For the purposes of section 22 of the Act, the rate of interest charged on money advanced by a pawnbroker shall not exceed 17%.

12. PARTICULARS OF SALE TO BE ENTERED IN REGISTER

For the purposes of section 33 of the Act, the particulars to be entered in the register in respect of a sale by a pawnbroker are -

- (a) the name and address of the pawnbroker;
- (b) the name and address of the pawner;
- (c) the date of the pawn;
- (d) the date of the expiry of the redemption period;
- (e) the name and address of the purchaser;
- (f) the date of the sale;
- (g) the amount for which the pawn was sold; and
- (h) that the sale is made pursuant to the Act.

13. APPLICATION FOR SUMMONS

An application under section 35(1) of the Act shall be in accordance with Form 7.

14. CHANGE OF ADDRESS

An application for the variation of a licence by a change of address shall be in accordance with Form 8.

15. SIGN TO BE DISPLAYED

For the purposes of section 37 of the Act, the dimensions of a sign shall be 30 cm x 40 cm.
