WORKMEN'S COMPENSATION (RATES OF COMPENSATION)  
REGULATIONS 1983

1. CITATION

These Regulations may be cited as the *Workmen's Compensation (Rates of Compensation) Regulations 1983*.

2. DEFINITION

In these Regulations, "Act" means the *Workmen's Compensation Act* as in force immediately before 1 July 1983.

3. AMENDMENT OF SECTION 10(1) OF THE ACT

Section 10(1) of the Act is amended by omitting "\$36,987" and substituting "\$50,000".

4. AMENDMENT OF SCHEDULE 2 TO THE ACT

Schedule 2 to the Act is amended -

- (a) by omitting from paragraph (1)(a) "\$36,987" (twice occurring) and substituting "\$50,000";
  - (b) by omitting from paragraph (1)(b) "\$14.85" and substituting "\$20.00";
  - (c) by omitting from paragraph (1)(c) "\$1,981.45" and substituting "\$2,680";
  - (d) by omitting from paragraph (1A)(b)(i)A "\$118.88" and substituting "\$161.00";
  - (e) by omitting from paragraph (1A)(b)(i)B "\$31.16" and substituting "\$41.00";
  - (f) by omitting from paragraph (1A)(b)(i)C "\$31.16" and substituting "\$41.00";
  - (g) by omitting from paragraph (1A)(b)(i)D "\$14.85" (twice occurring) and substituting "\$20.00";
  - (h) by omitting from paragraph (1A)(b)(i)E "\$14.85" and substituting "\$20.00";
  - (j) by omitting from paragraph (1A)(b)(i)F "\$14.85" and substituting "\$20.00";
  - (k) by omitting from paragraph (2)(a)(ii) "\$6,879.61" and substituting "\$9,300"; and
  - (m) by omitting from paragraph (8A) "\$1,486.09" (twice occurring) and substituting "\$2,010".
