AMENDMENTS OF THE CHILD WELFARE (CHILD MINDING) REGULATIONS

1. NEW REGULATION

The Child Welfare (Child Minding) Regulations are amended by inserting after regulation 9 the following:

"10. EXEMPTION FROM OUTDOOR PLAY SPACE REQUIREMENT

- "(1) Subject to sub-regulation (3), the Director may register under regulation 4(6) as a child minding centre a house or place which does not have an outdoor play space.
- "(2) A child shall not remain at a child minding centre referred to in sub-regulation (1) for a period longer than 3 hours in a 24 hour period.
- "(3) A child minding centre referred to in sub-regulation (1) shall conspicuously display at the child minding centre a copy printed in plain type of the notice appearing in Schedule 3.".

NOTICE

OUTDOOR PLAY SPACE

Under the Child Welfare (Child Minding) Regulations, this child minding centre has been registered as a child minding centre which does not have an outdoor play space. A requirement of this registration is that a child shall not remain at the child minding centre for a period longer than 3 hours in a 24 hour period. Could you please ensure that your child does not remain at this child minding centre in excess of that period."

3. FURTHER AMENDMENTS

The Child Welfare (Child Minding) Regulations are further amended as set out in the Schedule.
