AMENDMENTS OF THE PUBLIC HEALTH (SHOPS,
EATING HOUSES, BOARDING-HOUSES, HOSTELS
AND HOTELS) REGULATIONS

1. COMMENCEMENT

These Regulations shall come into operation on 1 January 1983.

2. APPLICATION FOR REGISTRATION

Regulation 13(1) of the Public Health (Shops, Eating Houses, Boarding-houses, Hostels and Hotels) Regulations is amended by omitting "one dollar" and substituting "\$40".

3. REGISTRATION

Regulation 36(1) of the Public Health (Shops, Eating Houses, Boarding-houses, Hostels and Hotels) Regulations is amended by omitting all words after and including "the

Second Schedule" and substituting "Schedule 2 and shall forward a fee of, where the application relates to a boarding-house where the number of rooms intended for use as a sleeping apartment for boarders -

- (a) is more than 2 and not more than 10 - \$40;
- (b) is more than 10 but not more than 20 - \$50;
- (c) is more than 20 but not more than 40 - \$60; and
- (d) is more than 40 - \$100."

4. FURTHER AMENDMENTS

The Public Health (Shops, Eating Houses, Boarding-houses, Hostels and Hotels) Regulations are further amended as set out in the Schedule.
