AMENDMENTS OF THE MOTOR VEHICLE DEALERS REGULATIONS

1. NEW REGULATION

The Motor Vehicle Dealers Regulations are amended by inserting after regulation 3 the following:

"3A. APPEAL AGAINST REFUSAL TO GRANT A LICENCE

"(1) For the purposes of section 12(5)(b) of the Act, a person whose application for a licence has been refused, or is deemed to have been refused, by the Commissioner may, within 14 days after -

(a) being served with the notice of the Commissioner's decision under that section; or

(b) the expiration of the 3 months period referred to in section 12(6) of the Act,

as the case may be, or such extension of that 14 days period as the magistrate allows, apply to a magistrate for a rehearing of the application.

(2) A magistrate to whom an application under sub-regulation (1) is made may rehear the application for the grant of a licence refused by the Commissioner, or deemed to have been refused, and at the rehearing shall have all the powers of the Commissioner in relation to the matter.

"3B. DECISION OF MAGISTRATE DEEMED TO BE THAT OF COMMISSIONER

A magistrate, on rehearing an application referred to in regulation 3A or an appeal under section 26 of the Act, may grant or refuse the application or appeal and his decision on the matter shall be deemed to be that of the Commissioner made at the time of and in place of the decision of the Commissioner to refuse the application for the grant of the licence or to revoke the licence, as the case may be.

2. SCHEDULE 6

Schedule 6 to the Motor Vehicle Dealers Regulations is amended by omitting items 3 and 4 and substituting the following:
