AMENDMENTS OF THE STOCK ROUTES AND TRAVELLING STOCK REGULATIONS

1. FEES FOR USE OF PUBLIC TRUCKING YARDS

Regulation 34 of the Stock Routes and Travelling Stock Regulations is amended by omitting sub-regulation (3) and substituting the following:

"(3) The fees payable under this regulation in respect of a public trucking yard shall be calculated at a rate of 50 cents for each head of cattle, horse, camel and buffalo.".

2. FURTHER AMENDMENTS

The Stock Routes and Travelling Stock Regulations is further amended as set out in the Schedule.
