WORKMEN'S COMPENSATION (RATES OF COMPENSATION)  
REGULATIONS 1981

1. CITATION

These Regulations may be cited as the Workmen's Compensation (Rates of Compensation) Regulations 1981.

2. COMMENCEMENT

These Regulations shall be deemed to have come into operation on and to have applied from 1 July 1981.

3. DEFINITION

In these Regulations, "Act" means the Workmen's Compensation Act as in force immediately before 1 July 1981.

4. AMENDMENT OF SECTION 10(1) OF THE ACT

Section 10(1) of the Act is amended by omitting "\$28,000" and substituting "\$31,640".

5. AMENDMENT OF SECOND SCHEDULE TO THE ACT

The Second Schedule to the Act is amended -

- (a) by omitting from paragraph (1)(a) "\$28,000" (twice occurring) and substituting "\$31,640";
- (b) by omitting from paragraph (1)(b) "\$11.25" and substituting "\$12.71";
- (c) by omitting from paragraph (1)(c) "\$1,500" and substituting "\$1,695";
- (d) by omitting from paragraph (1A)(b)(i)A "\$90" and substituting "\$101.70";
- (e) by omitting from paragraph (1A)(b)(i)B "\$23.60" and substituting "\$26.67";
- (f) by omitting from paragraph (1A)(b)(i)C "\$23.60" and substituting "\$26.67";
- (g) by omitting from paragraph (1A)(b)(i)D "\$11.25" (twice occurring) and substituting "\$12.71";
- (h) by omitting from paragraph (1A)(b)(i)E "\$11.25" and substituting "\$12.71";
- (j) by omitting from paragraph (1A)(b)(i)F "\$11.25" and substituting "\$12.71";
- (k) by omitting from paragraph (2)(a)(ii) "\$5,208" and substituting "\$5,885.04"; and
- (m) by omitting from paragraph (8A) "\$1,125" (twice occurring) and substituting "\$1,271.25".
