Regulations under the Motor Vehicles Act

AMENDMENTS OF THE MOTOR VEHICLES (REGISTRATION LABELS AND MISCELLANEOUS) REGULATIONS

1. COMMENCEMENT

These Regulations shall come into operation on a date to be fixed by the Administrator by notice in the Gazette.

2. PRINCIPAL REGULATIONS

The Motor Vehicles (Registration Labels and Miscellaneous) Regulations are in these Regulations referred to as the Principal Regulations.

3. DEFINITIONS

Regulation 5 of the Principal Regulations is amended by omitting the definition of "registration label".

4. ISSUE AND TYPE OF LABELS

Regulation 6 of the Principal Regulations is amended by inserting ", type" after "colour".

5. AFFIXING OF REGISTRATION LABELS

Regulation 7 of the Principal Regulations is amended -

(a) by omitting from sub-regulation (1) "20 feet" and substituting "6 metres";

(b) by omitting from sub-regulation (2)(a)(i) "windscreen;" and substituting "windscreen; or";

(c) by omitting from sub-regulation (2)(a)(ii) "windscreen." and substituting "windscreen; and"; and

(d) by omitting sub-regulation (2)(b), (c) and (d) and substituting the following:

"(b) in the case of a motor vehicle other than a motor vehicle to which paragraph (a) applies - the label shall be securely affixed to -

(i) the rear number plate of the motor vehicle, in such a manner that the characters on that number plate are not obscured; or

(ii) a place on the motor vehicle,  
as directed by the Registrar."

6. REPEAL

Regulations 8 and 9 of the Principal Regulations are repealed.

7. LABEL DESTROYED, DAMAGED, &c.

Regulation 11 of the Principal Regulations is amended -

(a) by omitting "or the period for which a trader's plate is issued"; and

(b) by omitting "3 dollars" and substituting "\$3".

8. LABEL TO BE DESTROYED ON EXPIRY

Regulation 12 of the Principal Regulations is amended -

(a) by omitting "or the period for which a trader's plate was issued"; and

(b) by omitting "or to whom the trader's plate was issued".

9. DESTRUCTION OF LABEL WHEN REGISTRATION IS CANCELLED,  
&c.

Regulation 13 of the Principal Regulations is amended by omitting sub-regulation (2).

10. OFFENCES IN RELATION TO REGISTRATION LABELS

Regulation 14(1)(a) of the Principal Regulations is amended by omitting "to which a trader's plate is affixed or".

11. OFFENCES

Regulation 19 of the Principal Regulations is amended by omitting "20 dollars" and substituting "\$100".
