AMENDMENT OF THE MOTOR VEHICLES (FEES AND CHARGES)  
REGULATIONS

1. COMMENCEMENT

These Regulations shall come into operation on 1 July 1980.

2. FEES AND CHARGES

Regulation 3 of the Motor Vehicles (Fees and Charges) Regulations is amended by omitting "Motor Vehicles Ordinance" and substituting "Motor Vehicles Act".

3. SCHEDULE

The Schedule to the Motor Vehicles (Fees and Charges) Regulations is amended by omitting the heading and matter relating to item 1 and substituting the following heading and matter:

"SCALE OF FEES PAYABLE UNDER THE MOTOR VEHICLES ACT

1.	Registration or renewal of registration of all motor vehicles or trailers:		
	(a) motor vehicles (other than motor cycles) with engine capacity -		
	(i) up to and including 3 litres, except engines with more than 4 cylinders and rotary engines	13(1)	\$13.50 per litre (minimum charge \$5.40 and maximum charge \$27.00)
	(ii) up to and including 3 litres and not included in subparagraph (i)	13(1)	\$15.00 per litre (minimum charge \$6.00)
	(iii) over 3 litres and up to and including 6 litres (irrespective of cylinders)	13(1)	\$45.00 plus \$20.00 per litre for each litre over 3 litres
	(iv) over 6 litres	13(1)	\$105.00 plus \$10.00 per litre for each litre over 6 litres
	(v) maximum charge for any tractor	13(1)	\$45.00
	(b) any vehicle powered solely by electricity (other than a motorcycle)	13(1)	\$12.00
	(c) trailers and caravans -		
	(i) trailers (except caravans) up to and including 0.5 tonnes	13(1)	35 cents per 25 kg
	(ii) trailers (except caravans) over 0.5 tonnes	13(1)	40 cents per 25 kg
