Regulations under the Supply of Services Act

AMENDMENTS OF THE WATER SUPPLY (TERMS AND CONDITIONS OF SUPPLY) REGULATIONS

1. APPLICATION

The amendments made by regulations 3 and 4 apply to and in relation to the charge period commencing on 1 July 1980.

2. REPEAL

Regulation 2 of the Water Supply (Terms and Conditions of Supply) Regulations is repealed.

3. WATER CHARGE

Regulation 24 of the Water Supply (Terms and Conditions of Supply) Regulations is amended -

(a) by omitting from sub-regulation (2)(b) "75 dollars" and substituting "\$50";

Water Supply (Terms and Conditions of Supply)

- (b) by omitting from sub-regulation (2)(c) "150 dollars" and substituting "\$100";
- (c) by omitting from sub-regulation (4)(a) "75 dollars" and substituting "\$50";
- (d) by omitting sub-regulation (4)(b) and substituting the following paragraph:
 - "(b) if the total quantity of water supplied exceeds 750 kilolitres, the sum of \$50 and -
 - (i) an amount calculated at the rate of 15 cents for each kilolitre or part of a kilolitre for the first 1,000 kilolitres of water supplied in excess of 750 kilolitres; and
 - (ii) an amount calculated at the rate of 20 cents for each kilolitre or part of a kilolitre of water so supplied in excess of 1,750 kilolitres.";
- (e) by omitting from sub-regulation (4A) all words after and including " and, in a charge period," and substituting the following:
 - "the amount of the charge payable under sub-regulation (4) for water supplied during a charge period shall be reduced -
 - (a) if the total quantity of the water so supplied does not exceed 300 kilolitres by an amount equal to 20 per cent of that charge;
 - (b) if the total quantity of the water so supplied exceeds 300 kilolitres but does not exceed 400 kilolitres by an amount equal to 15 per cent of that charge; and
 - (c) if the total quantity of the water so supplied exceeds 400 kilolitres but does not exceed 500 kilolitres by an amount equal to 10 per cent of that charge.";
- (f) by omitting from sub-regulation (5) "75 dollars" (twice occurring) and substituting "\$50";
- (g) by omitting from sub-regulations (6) and (7) "18 cents" and substituting "15 cents"; and
- (h) by omitting from sub-regulation (9) "60 dollars" and substituting "\$40".

3. PROPORTIONATE LIABILITY FOR WATER CHARGES

Regulation 28 of the Water Supply (Terms and Conditions of Supply) Regulations is amended -

Water Supply (Terms and Conditions of Supply)

- (a) by omitting from sub-regulation (2)(d) "75 dollars" (twice occurring) and substituting "\$50"; and
- (b) by omitting from sub-regulation (3) "75 dollars" (twice occurring) and substituting "\$50".

4. FURTHER AMENDMENTS

The regulations of the Water Supply (Terms and Conditions of Supply) Regulations specified in Column 1 of the Schedule are amended by omitting from the words specified in Column 2 of the Schedule in relation thereto and substituting the words, if any, specified in Column 3 of the Schedule in relation thereto.
