Regulations under the Dog Act

I, JOHN ARMSTRONG ENGLAND, the Administrator of the Northern Territory of Australia, acting with the advice of the Executive Council, hereby make the following Regulations under the Dog Act.

DOG REGULATIONS

1. CITATION

These Regulations may be cited as the Dog Regulations.

2. FORM OF REGISTER

- (1) For the purposes of section 11 of the Act, the prescribed form of register to be kept by a Registrar is Form 1.
- (2) For the purposes of section 11 of the Act, the particulars required by Form 1 are the prescribed particulars.

3. STERILIZATION MARK

For the purposes of section 13(c) of the Act, the prescribed manner of marking a dog which has been sterilized is by tattooing the dog on the left ear with the mark in Schedule 2.

4. DOG-TAG

For the purposes of section 17(b) of the Act, the form and type of dog-tag -

- (a) to be affixed to a dog registered in the year which ends on 30 June 1981 is prescribed as the form and type of dog-tag which would have been issued in respect of the dog under the repealed Acts; and
- (b) to be affixed to a dog registered in a year later than the year which ends on 30 June 1981 is prescribed as the form and type described in Schedule 3.

5. FORM OF APPLICATIONS

- (1) For the purposes of sections 15(2)(a) and 24(2)(a) of the Act, the prescribed form of application for the registration or the renewal of registration of a dog is Form 2.
- (2) For the purposes of sections 19(2)(a) and 26(2)(a) of the Act, the prescribed form of application for a licence or the renewal of a licence is Form 3.

6. STERILIZATION CERTIFICATE

For the purposes of section 22 of the Act, the prescribed form of sterilization certificate is Form 4.

7. PRESCRIBED REFUGES

For the purposes of section 50(b) of the Act, a refuge managed by the Society for the Prevention of Cruelty to Animals Incorporated and approved by the Minister is a prescribed refuge.

8. WARRANT

For the purposes of section 51(2) of the Act, Form 5 is the prescribed form of warrant.

9. HOURS OF POUND OPENING

For the purposes of section 55(b) of the Act, each pound shall remain open -

- (a) on a Saturday, a Sunday or a public holiday, other than Christmas Day or Good Friday between the hours of 8 o'clock in the morning and 12 noon; and
- (b) on a day which is not a Saturday, a Sunday or a public holiday between the hours of 8 o'clock in the morning and 5 o'clock in the afternoon.

10. NOTICE OF IMPOUNDING

For the purposes of section 56 of the Act, the prescribed form of notice of impounding is Form 6.

11. CHANGE OF OWNERSHIP OF DOG

For the purposes of section 64(1) of the Act, the prescribed particulars of the change of ownership of a dog are -

- (a) the name of the former owner;
- (b) the name of the present owner; and
- (c) the registration number of the dog.

12. FEES

- (1) For the purposes of the provisions of the Act specified in Column 1 of Schedule 4, the fee specified in relation to that provision is prescribed in Column 2 of that Schedule.
 - (2) Where -
 - (a) the Registrar is satisfied that the owner of a dog is in receipt of an aged, invalid or other pension; and
 - (b) the dog is required, for the first time, after 31 December in a year, to be registered and is registered before 30 June in the next year,

the owner of the dog is entitled to a rebate equal to one-half of the fee which would, but for this sub-regulation, be charged for the registration of the dog.

(3) Where the Registrar is satisfied that a registered dog has been sterilized since it was last registered or its registration was last renewed, as the case may be, but before 31 December in the year during which it was so registered, the Registrar shall refund to the owner of the dog an amount equal to one half of the fee for the registration of that dog.

FORM AND TYPE OF DOG-TAG

Section 17(b)

- 1. The area of the dog-tag shall not exceed 10 square centimetres.
- 2. The dog-tag shall -
 - (a) be constructed of aluminium or a light metal alloy;
 - (b) be not more than 2 millimetres thick;
 - (c) have smooth edges; and
 - (d) incorporate a split ring or similar fastening device, made of non-corrosive material, for attaching the dog-tag to the collar worn by the dog.
- 3. The dog-tag shall show -
 - (a) on one side the period for which the dog is registered and the words "Registered Dog" or a recognizable abbreviation thereof; and
 - (b) on the other side the number allocated to the dog in the register kept by the Registrar, prefixed by a number determined in respect of the Registrar by the Minister.
