WORKMEN'S COMPENSATION (RATES OF COMPENSATION)
REGULATIONS 1980

1. CITATION

These Regulations may be cited as the Workmen's Compensation (Rates of Compensation) Regulations 1980.

2. COMMENCEMENT

These Regulations shall come into operation on and apply from 1 July 1980.

3. DEFINITION

In these Regulations, "Act" means the Workmen's Compensation Act as in force immediately before 1 July 1980.

4. AMENDMENT OF SECTION 10(1) OF THE ACT

Section 10(1) of the Act is amended by omitting "25,000 dollars" and substituting "\$28,000".

5. AMENDMENT OF SECOND SCHEDULE TO THE ACT

The Second Schedule to the Act is amended -

- (a) by omitting from paragraph (1)(a) "25,000 dollars" (twice occurring) and substituting "\$28,000";
 - (b) by omitting from paragraph (1)(b) "10 dollars" and substituting "\$11.25";
 - (c) by omitting from paragraph (1A)(b)(i)A "\$80" and substituting "\$90";
 - (d) by omitting from paragraph (1A)(b)(i)B "\$21" and substituting "\$23.60";
 - (e) by omitting from paragraph (1A)(b)(i)C "\$21" and substituting "\$23.60";
 - (f) by omitting from paragraph (1A)(b)(i)D "\$10" (twice occurring) and substituting "\$11.25";
 - (g) by omitting from paragraph (1A)(b)(i)E "\$10" and substituting "\$11.25";
 - (h) by omitting from paragraph (1A)(b)(i)F "\$10" and substituting "\$11.25";
 - (j) by omitting from paragraph (2)(a)(ii) "4,650 dollars" and substituting "\$5,208"; and
 - (k) by omitting from paragraph (8A) "1,000 dollars" (twice occurring) and substituting "\$1,125".
