#### AMENDMENTS OF THE PAY-ROLL TAX REGULATIONS

# 1. INTERPRETATION

Regulation 3 of the Pay-roll Tax Regulations is amended by omitting "the Schedule" and substituting "Schedule 1".

# 2. NEW PART

The Pay-roll Tax Regulations are amended by inserting after Part III the following Part:

"PART IIIA - REFUNDS OF TAX UNDER SECTION 20A

# "27A. REFUND OF CERTAIN TAX

"For the purposes of section 20A(1) of the Act -

(a) each class of employees specified in Column 1 of Schedule 2 is prescribed;

- (b) in respect of each such class of employees, the date specified in Column 2 of Schedule 2 opposite that class is prescribed in relation to that class of employees; and
- (c) in respect of each such class of employees, the proportion of tax that was paid in respect of wages paid or payable after the date so prescribed is prescribed as the proportion specified in respect of that class in Column 3 of Schedule 2.".

#### 3. SCHEDULE 1

The Pay-roll Tax Regulations are amended by omitting the heading to the Schedule and substituting "SCHEDULE 1".

## 4. NEW SCHEDULE

The Pay-roll Tax Regulations are amended by inserting after Schedule 1 the following Schedule:
