Regulations under the Lottery and Gaming Act



AMENDMENTS OF THE LOTTERY AND GAMING REGULATIONS

1. Regulation 2A of the Lottery and Gaming Regulations is amended by omitting the definition of "the Board" and substituting the following definition:

Definitions

"the Commission" means the Racing and Gaming Commission constituted under Part IA of the Act;"

2. Regulations 10 and 10A of the Lottery and Gaming Regulations are amended by omitting "the Board" (wherever occurring) and substituting "the Commission".

3. Regulation 16 of the Lottery and Gaming Regulations is amended -

(a) by omitting sub-regulation (2); and

(b) by omitting from sub-regulation (3) "the Board" (wherever occurring) and substituting "the Commission".

Appeals

4. Regulation 22 of the Lottery and Gaming Regulations is amended -

(a) by omitting from sub-regulation (3) "regulation 21" and substituting "sub-regulation (2)"; and

(b) by omitting from sub-regulation (5) "subsection (5) of section 71" and substituting "section 71C(5)".

Repeal

5. Regulations 25 and 26 of the Lottery and Gaming Regulations are repealed.

6.(1) The Schedule to the Lottery and Gaming Regulations is amended by omitting from Forms 1 and 1A "section 93" and substituting "section 94TA".

(2) The Schedule to the Lottery and Gaming Regulations is amended by omitting Form 1B and substituting the following form:
