AMENDMENTS OF THE ASSOCIATIONS  
INCORPORATION REGULATIONS

1. Regulation 2 of the Associations Incorporation Regulations is repealed and the following regulation substituted:

"2. In these Regulations a reference to a form by number is a reference to the form so numbered in Schedule 1."

2. Regulation 3 of the Associations Incorporation Regulations is amended by omitting "Ordinance" and substituting "Act".

3. Regulation 4 of the Associations Incorporation Regulations is repealed and the following regulation substituted:

"4. For the purposes of section 5 of the Act, Form 1 is prescribed."

4. Regulation 5 of the Associations Incorporation Regulations is amended by omitting "Ordinance" and substituting "Act".

5. Regulation 6 of the Associations Incorporation Regulations is amended -

(a) by omitting from sub-regulation (1) "sub-section (1) of section 17 of the Ordinance" and substituting "section 17(1) of the Act"; and

(b) by omitting from sub-regulation (2) "of the Ordinance" and substituting "of the Act".

6. Regulation 8 of the Associations Incorporation Regulations is amended by omitting "Second Schedule" and substituting "Schedule 2".

7. The Associations Incorporation Regulations are amended by inserting after regulation 8 the following regulations:

"9. For the purposes of section 25A(2)(a) of the Act, Form 5 is prescribed.

"10. A certificate of incorporation of a trading association issued by the Registrar under section 25D(1) of the Act shall be in accordance with Form 6.

"11. For the purposes of section 25D(2)(d) of the Act, the ethnic communities specified in Schedule 3 are prescribed.

"12.(1) An application under section 25Z(1) of the Act for the issue to an incorporated trading association of a certificate of incorporation in a new name shall be in accordance with Form 7.

"(2) A certificate of incorporation in a new name issued to an incorporated trading association by the Registrar under section 25Z(1) of the Act shall be in accordance with Form 8.

"13. For the purposes of section 25AF(2)(a) of the Act the form set out in Form 9 is prescribed."

8. The First Schedule to the Associations Incorporation Regulations is amended by omitting "First Schedule" and substituting "Schedule 1".

9. Forms 1, 2, 3 and 4 of Schedule 1 to the Associations Incorporation Regulations are amended by omitting " Ordinance" and " Ordinance" (wherever occurring) and substituting "Act" and "Act" respectively.
