PLANNING REGULATIONS

1. These Regulations may be cited as the Planning Regulations.

Citation

2.(1) In these Regulations, "the Gazette" has the meaning ascribed to it in section 17 of the Acts Interpretation Act 1901 of the Commonwealth.

Interpretation

- (2) A reference in these Regulations to a form by number is a reference to a form so numbered in Schedule 1.
- 3. For the purposes of the sections of the Act specified in each of the following paragraphs the form specified in that paragraph is the prescribed form:

Excluded subdivisions

4. For the purposes of section 4 of the Act, the subdivisions specified in Schedule 2 are prescribed as excluded subdivisions.

Town areas

- 5. For the purposes of section 4 of the Act, the several areas of land specified in Schedule 3 are specified to be areas which are to be treated as towns.
- Consultation 6. For the purposes of section 43(1)(c) of the draft planning Act, the Secretary of the Department of Lands and instrument Housing is prescribed as the person with whom the Authority shall consult in the preparation of a draft planning instrument.

Prescribed subdivision application

7. For the purposes of section 88(1)(a) of the Act, the subdivision applications specified in Schedule 4 are prescribed as prescribed subdivision applications.

Consultation prescribed subdivision application

8. For the purposes of section 91 of the Act, the Secretary of the Department of Lands and Housing is prescribed as the person with whom the Authority shall consult when considering a prescribed subdivision application.

9. For the purposes of section 105(1)(a) of the Act, the development applications specified in Schedule 5 are prescribed as prescribed development applications.

Prescribed development application

10. For the purposes of section 108 of the Act, the Secretary of the Department of Lands and Housing is prescribed as the person with whom the Authority shall consult when considering a prescribed development application.

Consultation prescribed development application

11. For the purposes of section 136(1)(b) of the Act, the manner of service of an order requiring the attendance of any person before or the production of any documents to the Appeals Committee is personal service or service by leaving the order with a person apparently over the age of 15 years at the normal place of residence or business of the person on whom service is to be effected.

Service

12. Fees and expenses to be paid to witnesses under the Act to attend and give evidence shall be at the same rates, and subject to the same conditions, as the witnesses' expenses that are, from time to time, provided for under the Rules of Court made under section 86 of the Judiciary Act 1903 of the Commonwealth.

Witnesses' expenses

13. A register kept by a consent authority may be inspected by any person on payment of a fee of 50 cents to the consent authority.

Inspection of registers

14.(1) For the purposes of section 87(b) of the Act, the prescribed fee is \$50.

- (2) For the purposes of section 151(1)(b) of the Act, the prescribed fee is \$20.
 - (3) For the purposes of section 153(2)(b) of the Act, the prescribed fee for -
 - (a) a certified copy of a sheet or part of a sheet of the map or plan accompanying a planning instrument is \$20; and
 - (b) a certified copy of a page containing only writing from a planning instrument is \$1.

Block; thence easterly by the northern boundary of Block 167 and across a 20.12 m road to the most eastern northeastern corner of the said Block; thence northerly by the western boundary of Block 166 to the northwestern corner of the said Block; thence by a line across Florina Road to the most southern southwestern corner of Northern Territory Portion 1021; thence northwesterly westerly northerly and north-easterly by the southwestern southern western and northwestern boundaries of the said Portion; thence northerly by the western boundary of Northern Territory Portion 450 to the most eastern northeastern corner of Northern Territory Portion 1402; thence westerly and northwesterly by a northern and northeastern boundary of the said Portion to its intersection with the southeastern boundary of Northern Territory Portion 1401; thence generally northeasterly by the southeastern boundaries of the said Portion to the most eastern corner of the said Portion; thence by a line across the Stuart Highway and North Australia Railway to the point of commencement but excluding therefrom the Town of Katherine as notified in Gazette No. 66 of 13 August 1970.

SCHEDULE 4

Regulation 7

PRESCRIBED SUBDIVISION APPLICATIONS

- 1. Any subdivision of land which is outside a planning area declared under section 10 of the Act and -
- (a) which involves the creation of -
 - (i) not less than 50 lots; or
 - (ii) the opening of not less than one km of road;
 - (b) more than 50 per cent of which is subject to seasonal inundation exceeding 72 hours;
 - (c) which is more than 60 ha in area and which involves the creation of not less than 30 lots; or
 - (d) is within 100 m of a lake, billabong, river or foreshore.

Regulation 9

PRESCRIBED DEVELOPMENT APPLICATIONS

- 1. Any development application in respect of land not within a municipality within the meaning of the Local Government Act and within 100 m of land within a park or a reserve within the meaning of the Territory Parks and Wildlife Conservation Act.
- 2: Any development application in respect of development within 100 m of a lake, billabong, river or foreshore (development for the purpose of a park or reserve within the meaning of the <u>Territory Parks and Wildlife Conservation Act excepted</u>).
