Regulations under the Traffic Act

AMENDMENTS OF THE TRAFFIC REGULATIONS

1.(1) Regulations 1, 2 and 4 of these Regulations Commencement shall come into operation on the date on which Part II of the Traffic Act (No. 2) 1979 comes into operation.

- (2) Regulation 3 of these Regulations shall come into operation on the date on which Part III of the Traffic Act (No. 2) 1979 comes into operation.
- 2. Regulations 45A and 45B of the Traffic Regulations are repealed and the following regulations substituted:

"45A. For the purposes of section 8L(1) of the Prescribed Act, a device for the carrying out of breath analyses, breath being a device that -

- (a) is, or apparently is, of a type known as Breathalyzer; and
- (b) was manufactured, or apparently manufactured, under United States Patent Number 2824789,

is a prescribed breath analysis instrument.

Breath analysis

- "45B (1) A person shall not, at any time, use a prescribed breath analysis instrument for the purposes of the Act unless he has prepared it for use at that time.
- "(2) To prepare a prescribed breath analysis instrument for use at a particular time, a person shall, shortly before that time -
 - (a) flush out with air the chamber in which air or breath is collected for testing in the device to be used in the breath analysis;
 - (b) then pump air into that chamber through a solution of standard alcohol and carry out a test of that air by means of the device as if it were a breath analysis and record the temperature of the solution of standard alcohol and the results of the test expressed as a percentage of alcohol in blood as shown on the device; and
 - (c) then again flush out that chamber with air.
- "(3) A person shall not carry out a breath analysis of a sample of a person's breath for the purposes of the Act unless, shortly before the person submitting to the breath analysis gives a sample of his breath, the temperature recorded by the thermometer forming part of the device used in the breath analysis is not below 47 degrees celsius and not above 53 degrees celsius.
- "(4) A person shall not carry out a breath analysis of a sample of a person's breath for the purposes of the Act unless he is satisfied that that person has not consumed any intoxicating liquor within the period of 15 minutes immediately preceding the giving of the sample.

Testing instrument after use

"45C.(1) A person who has used a prescribed breath analysis instrument for the purposes of the Act shall, within a reasonable time after so using it, carry out the procedures referred to in regulation 45B(2)(a) and (b).

"(2) It is a sufficient compliance with sub-regulation (1) if the person who has used the instrument prepares it for further use for the purposes of the Act.

"45D. For the purposes of section 8J of the Act, a form of certificate set out in the Third Schedule may be used by the person and on the occasion indicated in the following table:

- 3. May be used by a member of the staff of a hospital after taking a sample of blood.
- 4. May be used by a member of the staff of a hospital after a person -
 - (a) refuses or fails to give a sample of his blood; or

- (b) refuses or fails to provide, in accordance with the directions of that member of the staff, a sample of his blood sufficient for the completion of a blood test to ascertain the concentration of alcohol in the blood of the person required to give the sample.
- 5. May be used by an authorized analyst after carrying out a blood test.
- May be used by an authorized analyst after preparing a batch of standard alcohol solution."
- 3. After regulation 45D of the Traffic Regulations the following regulation is inserted:

Breath testing stations

- "45E.(1) A member of the Police Force who sets up a breath testing station shall ensure that, at all times while the station is set up, a light is flashing on the vehicle that is parked at the station for the purpose of attracting the attention of motorists who are approaching the station.
- "(2) A member of the Police Force who is on duty at a breath testing station for the purpose of stopping motorists shall, subject to sub-regulation (3), wear uniform.
- "(3) A person shall not be held to have been not wearing uniform for the purposes of sub-regulation (2) by reason only that the uniform was partly covered by another garment or that a minor item of uniform was missing or incorrectly worn.".

CERTIFICATE ON COMPLETION OF BREATH ANALYSIS

I, the person who signed the above statement, a member of the Police Force of the Northern Territory authorized by the Commissioner of Police to use for the purposes of the Traffic Act a prescribed breath analysis instrument, namely the Breathalyzer manufactured under U.S. Patent No. 2824789, certify that the person, not being myself, named in the statement submitted to a breath analysis and, for that purpose, provided a sample of his breath, that I carried out the analysis, using a Breathalyzer manufactured under U.S. Patent No. 2824789, completing the analysis on the date and at the time specified in the statement, that the result of the analysis was the result specified in the statement and that I signed the statement and delivered the original to the person who provided the sample.

And I further certify that -

- (a) by the analysis I assessed that the person providing the sample had a concentration of alcohol in his blood of the number of grammes of alcohol per 100 millilitres of blood that is expressed as a percentage in the statement;
- (b) shortly before the analysis I carried out the procedure required by regulation 45B(2) of the Traffic Regulations, using a solution of standard alcohol supplied by an authorized analyst;
- (c) the temperature recorded by the thermometer forming part of the device, after each occasion on which I flushed out the chamber with air while carrying out that procedure was not below 47 degrees celsius and not above 53 degrees celsius;
- (d) before carrying out the analysis I satisfied myself that the person who provided the sample had not consumed any intoxicating liquor within the 15 minutes immediately preceding the giving of the sample;
- (e) I provided an unused mouthpiece for use in providing the sample; and;
- (f) after completing the analysis and before the time stated beneath my signature hereunder I carried out the procedures referred to in regulation 45B(2)(a) and (b) of the Traffic Regulations.
