Regulations under the Registration of Births, Deaths and Marriages Act

REGISTRATION OF BIRTHS, DEATHS AND MARRIAGES REGULATIONS

1. These Regulations may be cited as the Registration of Births, Deaths and Marriages Regula-Citation tions. 2. In these Regulations, unless the contrary intention appears-Interpretation "Act" means the Registration of Births, Deaths and Marriages Act; "Registrar" means the District Registrar of Births, Deaths and Marriages. s. 17A(1) of the Act 3.(1) An application to register the surname of a child under section 17A(1) of the Act shall be made by both parents of the child filing with the Registrar an application for registration of surname in accordance with Form 1 of the Sixth Schedule. (2) An application under sub-regulation (1) shall contain-(a) the full names, addresses and occupations of the applicants; the full names and place and date of birth of the child whose surname is sought to be (b) registered; (c) a declaration signed by both parents that they have agreed upon the name sought to be registered as the surname of the child; and (d) such other information as the Registrar may require. 4.(1) An application to amend the surname of a child under section 17A(6) of the Act shall be s. 17A(6) of the Act made by both parents of the child filing with the Registrar an application for change of surname in accordance with Form 2 of the Sixth Schedule. (2) An application under sub-regulation (1) shall contain-(a) the full names, addresses and occupations of the applicants; (b) the full names and place and date of birth of the child whose surname is sought to be registered; *Notified in the Northern Territory Government Gazette on 10 November, 1978.

 - (i) that the name sought to be registered is a name selected in accordance with the recognized custom or tradition of a particular ethnic group;
 - (ii) that one or both of the applicants is a member of the ethnic group referred to in subparagraph (i); and
 - (iii) that both applicants have agreed upon the name sought to be registered as the surname of the child; and
- (d) such other information as the Registrar may require.

5.(1) An application to register the surname of a child under section 17A(4) of the Act shall be made by both parents of the child filing with the Registrar an application for registration of surname in accordance with Form 3 of the Sixth Schedule.

- (2) An application under sub-regulation (1) shall contain-
- (a) the full names, addresses and occupations of the applicants;
- (b) the full names and place and date of birth of the child whose surname is sought to be registered;
- (c) a declaration signed by both applicants stating-
 - (i) that the name sought to be registered is a name selected in accordance with the recognized custom or tradition of a particular ethnic group;
 - (ii) that one or both of the applicants is a member of the ethnic group referred to in subparagraph (i); and
 - (iii) that both applicants have agreed upon the name sought to be registered as the surname of the child; and
- (d) such other information as the Registrar may require.

- 2. The surname of a child may be either:
 - (a) the surname of the father;
 - (b) the surname of the mother, if that is different to the surname of the father; or
 - (c) the surname of both parents in combination in either order and whether or not separated by a hyphen.

3. Subject to section 17A(4) and (6), which relates to traditional naming by ethnic groups, all children of a marriage whose names are registered in the Northern Territory must bear the same surname.
