category B means a camping area:

- (a) with a basic to moderate degree of site maintenance and facilities provided by the Commission, which may include toilet facilities, picnic tables, tap water and barbecues; or
- (b) classified by the Commission as a youth camping area or an outdoor education camping area and that has a variable degree of site maintenance and facilities.

category C means a camping area:

- (a) that is managed commercially under a permit issued by the Commission under by-law 13; and
- (b) that has a variable degree of site maintenance and facilities.
