1 Title

These Regulations may be cited as the *Local Government (General) Amendment Regulations 2021*.

2 Commencement

- (1) These Regulations, except regulations 4 and 5, are taken to have commenced on 1 July 2021.
- (2) Regulations 4 and 5 commence on the day on which these Regulations are notified in the *Gazette*.

137 By-laws proposed before commencement

- (1) Subregulation (2) applies if, before the commencement, a council:
 - (a) proposed to make a by-law under the former Act; and

-
- (b) complied with repealed section 190(1) in relation to the by-law;
and
 - (c) did not make the proposed by-law.
- (2) The council is taken to have complied with section 278(1) of the new Act in relation to the by-law after the commencement.
 - (3) This regulation is made under section 367 of the new Act.

138 By-laws made before commencement

- (1) Subregulation (2) applies if, before the commencement:
 - (a) a council made a by-law under Chapter 13, Part 13.1 of the former Act; and
 - (b) the by-law did not take effect.
- (2) The council is taken to have made the by-law under Chapter 13, Part 13.1 of the new Act after the commencement.
- (3) This regulation is made under section 367 of the new Act.

7 Repeal of Regulations

These Regulations are repealed on the day after the day they are notified in the *Gazette*.
