Part 1 Preliminary matters

1 Title

These Regulations may be cited as the *Firearms and Weapons Control Amendment Regulations 2024*.

2 Commencement

- (1) These Regulations, except Part 3, commence on the day after the day on which they are made.
- (2) Part 3 commences immediately after the commencement of Part 3 of the *Firearms and Weapons Control Legislation Amendment Act 2023*.
