#### 51 Methods of voting

Voting at a general meeting must be by:

- (a) written vote:
  - (i) if a poll is taken; or
  - (ii) if a person casts an absentee vote; or
- (b) otherwise show of hands.

#### 52 Resolutions

- (1) A motion is passed by an *ordinary resolution* if the motion is voted on at a general meeting of the Management Corporation and:
  - (a) if a poll is not taken under regulation 57 the votes counted in favour of the motion are more than the votes counted against it; or

- (b) if a poll is taken under regulation 57 the lot entitlements of the lots for the votes counted in favour of the motion exceed the lot entitlements of the lots for the votes counted against it.
- (2) A motion is passed by a **special resolution** if the motion is voted on at a general meeting of the Management Corporation and:
  - (a) at least two-thirds of the votes cast are counted in favour of the motion; and
  - (b) the lot entitlements of the lots for the votes counted against the motion do not exceed 25% of the aggregate lot entitlement of all lots.
- (3) A motion is passed by a **resolution without dissent** if the motion is voted on at a general meeting of the Management Corporation and no vote is counted against it.
